









Terms of Reference (TOR) For Individual Consultant for three days training of Common Interest Groups (CIGs)

Introduction:

Centre of Excellence for Rural Development (CERD) is a non-profit Organization registered with Securities and Exchange Commission of Pakistan (SECP) under section 42 of the companies' ordinance 1984. CERD is also Pakistan Centre of Philanthropy (PCP) certified CSO.

Description:

This programme is financed by Government of Italy through Director General for Development & Cooperation (DGDC) and supervised by the World Bank. The goal of the programme is poverty reduction through creation of sustainable social and economic development conditions, including increase in income and production capacity. The programme components are Social Mobilization or Institutional Development (ID), construction of small scale Community physical Infrastructure, Livelihood enhancement & Protection (LEP), Education, Health & Nutrition.











Under livelihood enhancement & protection component where qualified and Professional training consultants are required as per details given below.

Objective of the training:

To develop and improve Common Interest Groups capacity and business skills by providing a methodology and framework for improved profitability of the CIGs through strengthened links with markets and through preparation, implementation and follow up of business plans for the selected enterprises.

Scope of Work:

The scope of work includes;

- Must have 4 years of specific experience in imparting trainings in mentioned themes.
- Excellent report, presentation and communication skills
- Excellent report writing skills in English and Urdu and able to conduct and analyze pre and post training evaluation.
- Fluency in Pashto speaking will be preferred.
